NOTE ON THE PROCESS OF DUE DILIGENCE OF TOSS THE COIN LIMITED

We have been appointed as the Book Running Lead Manager for the proposed Initial Public Issue of **Toss the Coin Limited** ("TTCL" OR THE "COMPANY" OR THE "ISSUER"). As mandated under the SEBI (ICDR) Regulations, 2018, we herewith submit a brief note on the diligence process adopted by us:

Current business background, about the Operational Structure and the Business Strategy:

Two Executives of Beeline Capital Advisors Private Limited (Book Running Lead Manager to the Issue) had visited the registered office of the Issuer Company situated at Old No. 29, New No.62, Abhiramapuram 3rd Street, Abhiramapuram, Chennai - 600018, Tamil Nadu, India

- 1. They have inspected the Office Infrastructure, Staffing systems and Procedures etc w.r.t. the Company's business. They also have examined various documents including those relating to litigations, approvals, Disputes with statutory authorities etc. and other Material documents in connection with the finalization of the Red Herring Prospectus pertaining to the said issue.
- 2. They had discussions with the Board of Directors, Promoters, KMP's including the support staff regarding the business operations and related activities of the Company and gone through other documents / websites in order to further understand the actual procedures of business.
